1. INTRODUCTION

The Senior Citizens Benefit Fund (SCBF) was established in the late 1990 with the coming into force of the National Provident Fund Amendment Act 1990 in November 1990(Publicly Known as the Senior Citizens Benefit Fund Act) and the National Provident (Senior Citizens Benefit) Regulation 1990.

It would be understood that the SCBF provides monthly monetary pension payments to its beneficiaries for the general up keeping and maintenance of their particular way of life. Nothing however prevents the distribution of this benefit believed to be confined solely to the aged, to assisting and helping out with their family commitments and all other related obligations pertinent to their age and status in our country ,villages and church denominations.
